#### **III.Guest Speaker:**

**Who:** Catrin Wigfall, Policy Fellow at Center of the American Experiment (CAE) on The Future of Education in Minnesota – Introduced by Rita Hillman Olson

**What:** Catrin discussed her research into the continued decline of Minnesota Public Schools, MN schools introducing Critical Race Theory into K-12 schools, as well as the 1st Draft of the new Social Studies Standards (which is mandated by State Law to be updated every 10 years and NOT subject to Legislative oversight). Her research shows that MN schools overall and in particular inner city schools are failing miserably to teach our kids how to read and write and are focusing more on turning our students into activists through implementing CRT – which is founded on Marxism – now focusing on race instead of traditional class based Marxism. The education gap for minority students continues to worsen throughout Minnesota but especially for inner city kids in Minneapolis and St. Paul.

**Action Request(s):** Attend CAE's Raise Our Standards tour featuring Catrin and Kendall Qualls, get the word out to neighbors about CRT and the proposed Social Studies Standards (2<sup>nd</sup> draft due out in August), run for School Board, volunteer to review Textbooks (contact Catrin), get engaged with groups already fighting CRT and promoting school choice.
